

## Clinical Architecture End User Sublicense Agreement

THIS END USER SUBLICENSE AGREEMENT (the "Sublicense") is entered into between you as the "End User" and CLINICAL ARCHITECTURE, LLC ("Clinical Architecture") for use of components of Clinical Architecture's SYMEDICA L<sup>®</sup> product identified in your agreement with Altera hereto (the "Product"). The Product and the Altera Digital Health, Inc. ("Altera") software programs are separate products provided by separate entities.

End User is granted, subject to the terms of this Sublicense, a non-transferable, non-exclusive license to the Product. End User shall not: (a) decompile, disassemble, or reverse engineer any portion of the Product or otherwise attempt to determine source code or protocols from, or create derivative works or copies of, the Product; (b) assign, re-license, or sublicense the Product or the use of the Product; or (c) transfer, lease, loan, resell for profit, distribute, or otherwise grant any rights in the Product (or any output obtained from the Product ["Output"]) in any form to any other party, including commercial time-sharing, rental, or service bureau use.
