

## **Risk Management Consortium EULA**

**1. Sublicense.** The license to use the Risk Management Consortium, LLC ("**RMC**") Third Party Software is limited, non-exclusive and non-transferable. RMC reserves all rights in and to the RMC Third Party Software not expressly granted to Client under the Agreement or these RMC Specific Terms.

**2. Restrictions on Use.** Client agrees not to:

- 2.1. modify the RMC Third Party Software, excluding modifications approved in writing by RMC or contemplated and permitted as a feature of the RMC Third Party Software;
- 2.2. decompile, disassemble, translate or reverse engineer any of the RMC Third Party Software;
- 2.3. copy the RMC Third Party Software, other than for routine backup purposes or for use in accordance with these RMC Specific Terms, which authorized copying includes a reasonable amount of printing, copying, saving, and downloading of the content portions of the RMC Third Party Software through the functionality enabled in the RMC Third Party Software or any Altera Software, including for inclusion in patient medical records;
- 2.4. use any RMC Third Party Software to provide time sharing or service bureau services to third parties;
- 2.5. sublicense (other than to authorized users for Client's own internal business purposes as permitted by the Agreement), rent, lease, assign, or sell the RMC Third Party Software; or
- 2.6. remove, alter, or obscure any copyright, disclaimer, or other proprietary notice or any end user warning or advisory appearing in or on any of the RMC Third Party Software.

**3. Professional Judgment.** Client acknowledge that: (i) the content of the RMC Third Party Software is no substitute for individual patient assessment based upon the healthcare provider's examination of each patient and consideration of laboratory data and other factors unique to the patient; and (ii) the RMC Third Party Software should be used as a tool to help the user reach or understand diagnostic and treatment decisions, bearing in mind that individual and unique circumstances may lead the user or the user's healthcare provider to reach decisions not presented in or addressed by the RMC Third Party Software.

**4. Warranties.** RMC represents and warrants to Client at all times during the term of the sublicense granted under the Agreement for the RMC Third Party Software that:

4.1. *RMC Third Party Software.* The RMC Third Party Software will operate in accordance with its documentation and any published specifications in all material respects. The RMC Third Party Software do not contain any disabling devices or Viruses.

4.2. *RMC Third Party Software Content.* The content of the RMC Third Party Software has been authored, compiled by, or reviewed and approved by competent industry experts with reasonable care, after review and evaluation of applicable guidelines, standards, and reasonably current published medical literature, and is suitable for the purpose of supporting medical practitioners' diagnostic and treatment decisions relating to patient care which is provided in accordance with, but not as a substitute for, such practitioner's professional judgment based on accepted medical practices; provided that (i) RMC does not warrant or guarantee the completeness, correctness, accuracy, or timeliness of any content derived directly from current information provided by a product manufacturer, distributor or other third-party source whose reputation for providing such content is generally accepted in the medical industry and (ii) the Client acknowledges and agrees that the content of the RMC Third Party Software is only a subset of information available from the published medical literature at a given point in time reasonably prior to the release of any update. Updates are provided semi-annually.

**5. DISCLAIMER.** WITHOUT LIMITING ANY WARRANTIES PROVIDED BY ALTERA PURSUANT TO THE AGREEMENT AND EXCEPT FOR THE REPRESENTATIONS AND WARRANTIES EXPRESSLY SET FORTH IN THESE CLIENT SPECIFIC TERMS, CLIENT ACKNOWLEDGES AND AGREES THAT THE RMC THIRD PARTY SOFTWARE IS PROVIDED WITHOUT WARRANTY OF ANY KIND, EXPRESS OR IMPLIED, ON AN "AS IS" BASIS.

**6. LIMITATION OF LIABILITY.** RMC AND CLIENT EACH ACKNOWLEDGES AND AGREES THAT, TO THE MAXIMUM EXTENT PERMITTED BY LAW, NEITHER HAS ANY LIABILITY TO THE OTHER (WHETHER BASED IN WARRANTY, CONTRACT, TORT OR OTHER LEGAL THEORY, AND WHETHER OR NOT ADVISED OF THE POSSIBILITY OF SUCH DAMAGES) FOR: (i) INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES (INCLUDING LOST PROFIT, LOST DATA, OR DOWNTIME COSTS) OR (ii)

ANY AMOUNTS IN EXCESS, IN THE AGGREGATE, OF THE FEES PAID OR OWED UNDER THE AGREEMENT FOR THE RMC THIRD PARTY SOFTWARE DURING THE TWELVE (12) MONTH PERIOD IMMEDIATELY PRECEDING THE FIRST EVENT, ACTION OR OMISSION GIVING RISE TO LIABILITY FOR WHICH DAMAGES ARE RECOVERED. Notwithstanding the foregoing, RMC acknowledges that it has certain contractual obligations to Altera that may make RMC liable to Altera for certain liabilities, representations and warranties in connection with claims made by a Client against Altera, including for third party claims that Client's use of the RMC Third Party Software infringes or misappropriates a third party's intellectual property rights.

7. **Rights Upon Termination.** Upon expiration or termination of sublicense granted to Client under the Agreement for the RMC Third Party Software, Client shall have the irrevocable right to use the RMC Third Party Software only to the extent any content in the RMC Third Party Software is incorporated in or otherwise used in or by the records already created by Client before such termination or expiration. No other ongoing use of the RMC Third Party Software is permitted.
